If you believe that your premises are being bugged, watched or listened to by unauthorised persons we ask that you should be cautious about how you go about the detection process. If you believe that information is being intercepted by listening or video camera devices you shouldn't discuss the suspicion within the confines of the area you believe is being unlawfully intercepted. The most secure location to discuss your suspicions about being bugged is away from the premises of concern. You shouldn't attempt to use a landline from the premises that you suspect is being bugged, rather contact us when you are well away from the area of concern via a mobile cell phone or better still a public telephone that you would never normally use. If your business is being bugged it is quite possible that your home premises are being bugged and your vehicle may also be being bugged or tracked.

To contact Lynch Investigations & Countermeasures the most secure way to use is by using a mobile cell phone, email or using a public telephone well away from the premises of concern. Don't attempt to contact us from a mobile cell phone from inside of a motor vehicle for the motor vehicle could also be fitted with a listening device or video/audio camera.

We at Lynch Investigations & Countermeasures know that the detection of listening devices, hidden video cameras and tracking devices shouldn't be carried out during normal trading hours for discretionary reasons but if for some reason you may suspect that the listening devices or hidden video cameras are operating through normal business hours only, we can arrange with you to visit the area of concern at any time suitable 24 hours 365 days of the year.
